1. Power of attorney (Resolution in case of tenderers being Truck Operators Unions) authorizing a person or persons to sign the bids should be duly attested by Executive Magistrate/Notary Public.
2. Power of attorney, Partnership deed in case of partnership firm duly attested by the executive Magistrate /Notary Public.
3. Bank statement showing transaction of minimum last six months duly authenticated by the competent authority of bank in respect of the firm /company/Union/co-operative.
4. Certificate from the scheduled bank for maintaining over draft (O.D.), C.C. Limit.
5. Certified/Attested copy of the latest income Tax return of last three years.
6. Turnover of last three years as per balance sheet submitted to Income Tax Deptt. duly certified by CA.
7. Service Tax No. (copy be attached)

TERMS AND CONDITIONS FOR THE CONTRACTOR FOR HANDLING AND TRANSPORTATION OF SUGAR FOR THE PERIOD FROM JUNE, 2014 TO MARCH 2015.

1. The contract shall come into force from the date on which Hafed Sugar Mill, Assandh issues letter of acceptance or any other instrument convenient to the Mill. In the case of bidder refuses to perform the job on the rates quoted by him, his security deposit shall be forfeited without notice and such tenderer shall be debarred for participating in any future tenders.
2. Not with standing anything to the contrary contained in the tender the contract shall be governed by the terms and conditions herein stipulated.

3. PROCESSING FEE AND EARNEST MONEY

- 3.1 The tenderer shall furnish EMD of Rs. 2,00,000/- (Rs two lac only) along with the tender documents in the shape of bank draft or RTGS in HDFC Bank Ltd. Account No. 13271450000256 in the favour of "Hafed Sugar Mill, Assandh (IFSC code HDFC 0001327) accompanied by documentary proof in the token of having deposited the earnest money, in the case of amount deposited /remitted trough RTGS with UTR No. & dated with name of the Bank.
- 3.2 Earnest money received from the tenderer will be refunded to such unsuccessful tenderers within 20 days from the date of finalization of the tender/ quoted rates.

4 TRANSPORTATION WORK

The entire process shall involve taking a delivery from sugar mills, to H.P. State Civil Supply corporation`s different godowns (list attached) in Himachal Pradesh.

- 5 The contractor shall be responsible for the transportation /protection of sugar from natural/unnatural calamities at his own cost.
 - 5.1 The total quantity of quantity of sugar to be supplied to various locations has been given in attached sheets, but it may vary as per the requirement of H.P. State Civil Supply Corporation.
 - 5.2 The contractor shall have to take delivery of sugar from the Hafed Sugar Mill, Assandh or other Sugar Mill if required i.e. from Karnal, Jind, Kaithal etc. as per dispatch plan given to him and will deliver the same to Incharges of the godown at destinations against a proper lorry receipt duly authenticated by the godown Incharge.
 - 5.3 The contractor will be responsible to lift the sugar within the time period as specified by the Hafed Sugar Mill, Assandh and supply to H.P. Civil State Supply Corporation Ltd. Shimla as per their dispatch plan. The contractor will submit the receipt of the incharge of the HP Civil Supplies with their seal.
 - 5.4 The contractor shall have to carry out the work during the contractual period as per directions issued by The General Manager, Hafed Sugar Mill, Assandh. or any person authorized by him.
 - 5.5 The tenderer shall have to submit the photocopy of Registration No. in respect of union/ Cooperative /company/firm with telephone/fax numbers.

- 5.6** The tenderer shall have mentioned in the tender, the name of the party/proprietor partner (in the case of partnership, copy of partnership deed to be enclosed). In the case of company particulars of Directors/ M.D. or agents etc. and in the case of truck Operator Union/ Coop. societies, Memorandum of association/ articles of association/ constitution of the union & registration no. etc. if any, shall have to be furnished.
- 5.7** The tenderer shall have to mention the name of their representative with address and telephonic no./fax no. of such branch offices in case situated at Headquarter of Mill concerned.
- 5.8** The tenderer shall have to submit the copy of Experience Certificate/copy of the work order etc., about transportation business of sugar /food grains/other goods along with tender with detail of the regular clients for the past five years with their names and address an proof of having executed their work as well as present work if any, in hand at the concerned station from where levy/ non levy sugar transport contract is to be executed.

- a) The tenderer shall have to furnish the detail in respect of numbers of trucks owned by the company/firms/union/coop. society/Party along with RTO Certificate duly passed by The RTO and at least the ten trucks should be owned by the tenderer.
 - b) Capacity to mobilize trucks from associates /other sources (Please attach attested photocopies of minimum 15 trucks RTO registration of associated trucks and also furnish a letter from their owners that they are agreeable to supply their trucks the tenderer).
 - c) In the case of Truck union, list of members along with the truck no. with RC's of a minimum 15 trucks duly passed by the transport authority should be attached.
- 5.9** Only such tenderers shall be allowed to participate whose annual turn- over (of the last three last years) is not less than Rs. 1.00 crore (Rs. one crore only) in the transportation business.
- 5.10** Certified copies of the balance sheet for the last three years be attached along with the documents.
- 5.11** The detail of moveable and immoveable property i.e. Agriculture and Other land, immoveable property with proof of processing such properties be attached with tender documents.
- 5.12** The tenderer shall mention in the tender the name and address of the bankers with the telephonic number, cash credit limit of the party (Please attach latest bank certificate).
- 5.13** The tenderer shall provide the solvency certificate from his/her banker as a proof for the financial liability and credit worthiness of the concerned.
- 5.14** The tenderer shall provide the attested photocopies of latest income certificate and PAN number.
- 5.15** A copy of receipt towards cost of tender documents deposited with the corporation be enclosed with technical bid.
- 5.16** At the time of opening of tenders only technical bids containing EMD & copy of receipt along with all requisite documents would be opened and financial bid would be opened only of those tenderer who qualify the technical scrutiny.
- 5.17** Only one set of documents of all requisite documents be enclosed in the envelope containing technical bid as per terms and conditions of the tender for quoting rate of

transportation of levy/non levy sugar for other states also in such case he shall furnish only one set of all requisite documents for transportation of levy/non-levy sugar. Tender shall be required to submit technical bid separately in respect of other state in the envelope containing technical bid duly signed and stamped.

- 6 It shall be responsibility of the contractor to keep available adequate number of trucks to transport the material entrusted to him, conforming to all Govt. regulations immediately on the same day. In case of failure on the part of the contractor to provide sufficient no. of vehicles, the mill shall be at liberty to obtain the necessary transport from any source and recover extra cost, if any, thereof from the contractor.
- 6.1 Due to failure/fault of transporter to lift sugar from Hafed Sugar Mill, Assandh and if any other Sugar Mill or delay during transit beyond 3 days from the date of lifting and supply date.
- 6.2 In case non supply/delayed supply as per the delivery schedule of HP State, liquidated damage for delay in supply shall be recovered to be computed @ 1% for 1st week, @3% for 2nd week and 5% for 3rd week and 10% for 4th week of the quantity of delay supplied by the Transport Contractor. The rate of sugar will be calculated @ 3847/- Per Qtl. for penalty purpose.
- 6.3 In case of delay in supplying the vehicle against booking on telephone on the same day, the transporter/contractor will be liable for late penalty for Rs. 1000/- per day per truck in addition to the clause No. 6.2.
- 6.4 In case the transport contractor still fails to supply the Sugar, Hafed shall have the right to make arrangement for supply of sugar at the risk & cost of the contractor and incidental charges incurred their on this account shall be deducted from their due payments as well as from the security deposit.
- 6.5 In addition to above, any penalty imposed by H.P. Civil State Supply Corporation Ltd. for late supply of sugar will be recovered and deducted from their transportation payment. The General Manager, Hafed Sugar Mill, Assandh will be sole deciding authority for imposing penalties on such delays.
- 7 The contractor shall take all diligent steps to ensure that material while in transit and during handling time is not damaged due to conditions of weather or otherwise. The penalty will be calculated for such damages at the open market sale rat of sugar the amount of penalty shall be recovered from the outstanding bills or from the security deposit, (and if need be from both) without any reference/ show case notice to the contractor.
- 8 From the time of material is loaded in the trucks and till the same is delivered at the specified destination, the contractor shall be completely and solely responsible for the material against damage on account of fire, rain, accident, shortage, deterioration, loss or pilferage of material shall be recovered in full form the outstanding bills and the security deposit of the contractor without prejudice to any other remedy in law.
- 9 Hafed Sugar Mill, Assandh reserves the right to award parallel contract without giving any notice to the contractor or to terminate this contract at any time by giving 15 days notice if the services of the contractor are found unsatisfactory.

- 10 The freight will be paid on actual quantity of sugar supplied to H.P State Civil Supplies destinations. The quantity of sugar can be reduced than truck load as per requirement. In one truck load of sugar can also supplied to different destinations.
- 11 Hafed reserves the right to accept / reject any/ all tenders without assigning any reason.
- 12 After the final acceptance of the tender by the tender committee, no request for further increase of rate shall entertained.
- 13 The earnest money of the second lowest bidders should be kept pending for 20 days till the agreement be made with the L-1.
- 14 The contract to L-2 is also be made if L-1 not been able to work as per terms and not made the agreement with Hafed.

15 RATE FOR THE WORK

- 15.1 The rates are to quoted as specified in the Annexure–II (financial bid). Each page of Annexure–II shall be signed by the tenderer or his authorized signatories.
- 15.2 The tenderer will quote rates as percentage above or below the basic rates (on net weight) inclusive of dala charges and insurance & tax liable etc, if any as applicable time to time.
- 15.3 The dala charges if any will be paid by the transporter with mutual settlement with labour. Hafed work should not be suffered due to dispute of any problem, otherwise the transporter/contractor will be responsible for the losses suffered by Hafed in this regard.
- 15.4 If committee considered that the rates are not genuine, than negotiation will be held by the committee.
- 15.5 The contractor shall not demand any increase in the rates quoted/negotiated by him during the contract period.
- 15.6 Conditional tenders will not be entertained.
- 15.7 The contractor shall provide the transit insurance of every truck load of sugar. The prevailing rate of sugar is 3847/- per qtl. The insurance may be supplied on these rates.
- 15.8 The period can be extended by Hafed for further three months i.e. upto June,15 on the same terms and conditions settled with Hafed.

16 SECURITY DEPOSIT

- 16.1 The successful tenderer has to deposit a security amount of Rs. 20.00 Lacs (Rs. twenty lac only) including earnest money by an irrecoverable Bank Guarantee/Demand Draft within five days of the award of tender.
- 16.2 The security deposit/bank guarantee will be refunded to the contractor after two months after satisfactory completion and faithful performance of the contract on recovery of outstanding dues, if any. No interest shall be payable on Earnest Money and Security Deposits.
- 16.3 Any other dues outstanding against the contractor shall also be recovered from the security deposit of the contractor.
- 16.4 The successful tenders/ transporter shall execute an agreement with GM, Hafed Sugar Mill, Assandh after award of work within 5 days.

17. PAYMENT.

Payment will be made within ten working days after submission of bills alongwith GTRs duly signed acknowledgment of sugar receipt from their authorized signature with seal, through account payee's cheque only on fortnightly basis.

18. All legal matters, relating to vehicles, employees of transporter shall be exclusively responsibility of the transporter. In case of vehicle being detained by the authorities or any other reasons, the loss of good or their quantity shall be made from the contractor/transporter.
19. The transporter will carry the material as per permissible limit.

20. CERTIFICATE

The payment of freight would be released from Hafed Sugar Mill, Assandh on providing proof of receipt of the consignment at destination duly authenticated by the authorized representative of HP Civil Supplies representative with their seal.

21. DEDUCTIONS/PENALTIES

- 21.1 Income tax plus surcharge if any shall be deducted from the transporter out of his freight bills at any time of making freight payment as per statutory orders/rules in this regard from time to time.
- 21.2 In case non supply/delayed supply as per the delivery schedule of HP State, liquidated damage for delay in supply shall be recovered be computed @ 1% for 1st week, @3% for 2nd week and 5% for 3rd week and 10% for 4th week of the quantity of delay supplied by the Transport Contractor. The rate of sugar will be calculated @ 3847/- Per Qtl. for penalty purpose.
- 21.3 In case the contractor declines or neglects to perform contract or delays dispatches or furnish incorrect information at any time, The Hafed Sugar mill have right to get the work done from other sources at the risk and cost of the contractor. The contractor will be fully responsible for all damages direct or indirect on this account. Further, the G.M. of the sugar mill in such cases may impose any penalty, which may be deemed fit including forfeiture of security, apart from cancellation of contract without any notice.

22. BEACH OF CONTRACT

In case of breach of any terms and conditions of the tender or contract by the contractor arising from this tender/contract the Hafed Sugar Mill shall be entitled for:-

- i) Forfeiture the security deposit;
- ii) Termination of contract;
- iii) To have contract work executed through others and
- iv) Recover the entire loss on this account from the contractor without any notice.

23. INDEMNITY

Hafed Sugar Mill shall not liable for any action direct or indirect that may be instituted against the contractor by any person or body of the persons in relation to transport or handling of the material under this tender or any contract arising there from or any consequent liability. The contractor shall be liable to keep this sugar mill fully indemnified on that behalf.

24. DOCUMENTATION

The contractor shall comply with all the documentation and procedural formality as instructed by the sugar mill from time with respect to proceeding to specified destination, entering the warehouse or railway yards etc. The contractor shall be liable to pay damages to the sugar mill arising out of any failure on his part or his staff to comply with all statutory regulations pertaining to sugar movement.

25. ASSIGNMENT OR TRANSFER

Contractor shall not sublet, transfer or assign the contract or any part thereof to any other party without prior written approval of the Hafed Sugar Mill, Assandh.

26. ARBITRATION

All disputes arising out of or touching or concerning any matter whatsoever, this tender or this contract arising there from shall be referred to The managing director Hafed who shall act as the sole arbitrator and his decision shall be final and binding on the both parties.

27. Force Majeure

The terms and conditions hereof shall be subject to force majeure.
