The Federation is engaged in the procurement and storage of food grains, coarse grains, oil seeds and pulses as per the policies of the State Government and the Government of India.

### **2. ABOUT TENDER**

Expression of Interest response invited from Central PSUs and State PSUs for providing Consultancy services on Turnkey basis to setup CCTV Surveillance System at various location of HAFED warehouses through a competitive bidding process in accordance with the procedure set out herein. ## **5. DUE DILIGENCE BY BIDDERS**

BIDDERS are encouraged to inform themselves fully about the assignment and the local conditions before submitting the bids. Written queries can be sent to HAFED by date and time specified in this RFP.

## **6. BRIEF DESCRIPTION OF SELECTION PROCESS**

- 6.1 HAFED will adopt a two-stage selection process (collectively the “Selection Process”) in evaluating the bids comprising prequalification and technical bids.
- 6.2 In the first stage, a prequalification evaluation will be carried out as specified in this RFP. Only prequalified bids will be eligible for technical evaluation.
- 6.3 In the second stage, a technical evaluation will be carried out as specified in this RFP. Based on the technical evaluation, selected Bidder will be awarded to execute the project on turnkey basis.
- 6.4 The Proposal evaluation process is detailed in this RFP. The details of eligibility criteria are provided in this RFP.

## **7. CURRENCY FOR PAYMENT**

All payments to the Bidder shall be made in INR in accordance with the provisions of this RFP.

## **8. SCHEDULE OF SELECTION PROCESS**

HAFED would endeavor to adhere to the key dates as provided in the beginning of the RFP.

## **10. INSTRUCTIONS TO BIDDERS**

10.1 **Scope of the Bid:**

- i. Detailed description of the objectives, scope of services, deliverables and other requirements relating to this Consultancy are specified in this RFP. Any Central/ State PSU that has necessary requisite experience and capabilities required for undertaking this assignment, can participate in the Selection Process in response to this RFP. The manner in which the Proposal is required to be submitted, the manner it is evaluated and accepted is explained in this RFP.

- ii. BIDDERS are advised that the selection of Consultant shall be on the basis of an evaluation by HAFED through the Selection Process specified in this RFP. BIDDERS shall be deemed to have understood and agreed that no explanation or justification for any aspect of the Selection Process will be given and that HAFED's decisions are final and binding without any right of appeal whatsoever.
- iii. The Bidder shall submit its bids in the form and manner specified in this Section of the RFP. The Technical bid shall be submitted in the forms as detailed in the RFP.

**10.2 Eligibility of Bidder – Pre-qualification Criteria:**

- i. BIDDERS must read carefully the pre-qualification criteria provided herein. Bids of only those BIDDERS who satisfy the pre-qualification criteria will be considered for technical evaluation.
- ii. To be eligible for evaluation of its Proposal, the Bidder shall fulfill the following Pre-qualification criteria:

- iii. The Bidder should submit a Power of Attorney for Authorized signatory.
- iv. While submitting a Proposal, the Bidder should attach clearly marked and referenced continuation sheets in the event that the space provided in the specified forms in the Appendices is insufficient. Alternatively, BIDDERS may format the specified forms making due provision for incorporation of the requested/relevant information.

**10.3 Number of Bids:**

No Bidder shall submit more than one Application for the Consultancy. A Bidder applying individually shall not be entitled to submit another application.

**10.4 Cost of Bids:**

The BIDDERS shall be responsible for all of the costs associated with the preparation of their bids and their participation in the Selection Process including subsequent negotiation, visits to the HAFED etc. HAFED will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the Selection Process.

**10.5 Visit to HAFED:**

BIDDERS are encouraged to submit their respective bids after visiting HAFED and ascertaining for themselves the availability of any relevant documents and other data, applicable Laws and regulations or any other matter considered relevant for the preparation of the bids.

**10.6 Acknowledgement by Bidder:**

**10.6.1** It shall be deemed that by submitting the bids, the Bidder has:

- i. made a complete and careful examination of the RFP;
- ii. received all relevant information requested from HAFED;
- iii. accepted the risk of inadequacy, error or mistake in the information provided in the RFP or furnished by or on behalf of HAFED;
- iv. satisfied itself about all matters, things and information, including matters referred to in herein above, necessary and required for submitting an informed Application and performance of all of its obligations there under;
- v. acknowledged that it does not have a Conflict of Interest; and
- vi. Agreed to be bound by the undertaking provided by it under and in terms hereof.

**10.6.2** HAFED shall not be liable for any omission, mistake or error in respect of any of the above or on account of any matter or thing arising out of or concerning or relating to RFP or the Selection Process, including any error or mistake therein or in any information or data given in this RFP.

**10.7 Right to reject any or all bids:**

**10.7.1** Notwithstanding anything contained in this RFP, HAFED reserves the right to accept or reject any Proposal and to annul the Selection Process and reject all Bids, at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons thereof.

**10.7.2** Without prejudice to the generality of Clause, HAFED reserves the right to reject any Proposal if:

- i. At any time, a material misrepresentation is made or discovered, or
- ii. The Bidder does not provide, within the time specified, the supplemental information sought for evaluation of the Proposal. Misrepresentation/ improper response by the Bidder may lead to the disqualification of the Bidder. If such disqualification / rejection occurs after the bids have been opened and the highest ranking Bidder gets disqualified / rejected, then HAFED reserves the right to consider the next best Bidder, or take any other measure as may be deemed fit in the sole discretion of HAFED, including annulment of the Selection Process.

**10.8 Clarifications:**

- i. BIDDERS requiring any clarification on the RFP may send their queries in writing (email) before as mentioned in the key dates in the beginning of the RFP. HAFED shall endeavor to respond to all queries before 3 Days of the submission date. Replies to all such queries shall be posted on the Official Website without identifying the source of queries.



- ii. HAFED reserves the right not to respond to any queries or provide any clarifications, in its sole discretion, and nothing in this Clause shall be construed as an obligation to respond to any question or to provide any clarification.

**10.9 Amendment of RFP:**

- i. At any time prior to the deadline for submission of Proposal, HAFED may, for any reason, whether at its own initiative or in response to clarifications requested by a Bidder, modify the RFP document by the issuance of Addendum/ Amendment and posting it on the Official Website.
- ii. All such amendments will be posted on the Official Website along with the revised RFP containing the amendments and will be binding on all BIDDERS.
- iii. In order to afford the BIDDERS a reasonable time for taking an amendment into account, or for any other reason, HAFED may, in its sole discretion, extend the Bid submission date.

**10.10 Language:**

Bids with all accompanying documents (the “Documents”) and all communications in relation to or concerning the Selection Process shall be in English language and strictly on the forms provided in this RFP. No supporting document or printed literature shall be submitted with the Proposal unless specifically asked for and in case any of these Documents is in another language, it must be accompanied by an accurate translation of all the relevant passages in English, in which case, for all purposes of interpretation of the Proposal, the translation in English shall prevail.

**10.11 Format and signing of Proposal:**

- i. The Bidder shall provide all the information sought under this RFP. HAFED would evaluate only those Bids that are received in the specified forms and complete in all respects.
- ii. The Proposal, shall be typed or written in indelible ink and signed by the authorized signatory of the Bidder who shall initial each page. In case of printed and published Documents, only the cover shall be initialed. All the alterations, omissions, additions, or any other amendments made to the Proposal shall be initialed by the person(s) signing the Proposal.
- iii. BIDDERS should note the BDD, for submission of Bids. Except as specifically provided in this RFP, no supplementary material will be entertained, and that evaluation will be carried out only on the basis of Documents received by the closing time of BDD. BIDDERS will ordinarily not be asked to provide additional material information or documents subsequent to the date of submission, and unsolicited material if submitted will be summarily rejected.

**10.12 Bid Securing Declaration:**

- i. Bidders shall submit Bid Securing Declaration (BSD) in a sealed envelope tiled “EOI for SITC of CCTV Surveillance System at various Warehouses of HAFED, Haryana” to the HAFED authorities. Scanned copy of BSD also needs to be submitted through e-mail/ manual. If the BSD is not received by the prescribed date and time, the proposal submitted by the bidder will be liable to be summarily rejected.

- ii. Bidder has to submit BSD to the email (in PDF format only)/ manual in Hard copy, at least a day or 24 hours before the closing of Last date/time of Bid Submission. Receipt of successful submission of BSD has to be submitted through email/ manual with the Technical bid. If not complied, bid will not be considered for opening and rejected out-rightly.
- 10.13 **Performance Security cum Performance Guarantee:**
- i. Security Deposit for proper and timely fulfillment of the contract has to be furnished by the successful Bidder within 07 working Days from the date of Agreement cum receipt of work order and also required to furnish a guarantee on a stamp paper of 100/- duly attested by a Notary Public to the effect that he shall maintain Secrecy and Confidentiality of the documents. No exemption will be made.
  - ii. The Performance Security cum Performance Guarantee of INR 02 Lac only by furnishing a Bank guarantee or Demand Draft or Fixed Deposit Receipt issued by a Nationalized/ Scheduled Bank approved by RBI drawn in favor of the "The Haryana State Cooperative Supply and Marketing Federation Limited" payable at "Chandigarh/ Panchkula". The Security Deposit can also be made in the shape of Guarantee Bond executed by a Nationalized/ Scheduled Bank.
  - iii. The Performance Security cum Performance Guarantee could be made for a period of 1 year initially, subject to its revision at the start of every year, till completion of contract period.
  - iv. Security Deposit will be retained by the Department till satisfactory completion of the work. It should be clearly understood that in the event of the Contract not being executed and completed as per the quality and time schedule laid down, the same is liable to be forfeited. This will be in addition to the penalty, if any, which may be imposed as specified in the delivery schedule.
  - v. HAFED authority will return the PBG within 30 Days of completion of contract period.
- 10.14 **Financial Proposal:**
- 10.15 Selected Bidder, having the highest Technical score out of 100 marks as per Section 11 of this RFP, will be awarded the project on Turnkey basis at 04.00 % of Total project value as per Scope of work of this tender.
- 10.16 Every bidder has to give Undertaking on their Letter head inline with Performa 13 of this RFP and complying with clause 10.15.1 and signed by the Bidder's authorized representative. Any deviation to this clause will attract bid rejection automatically and will not be evaluated further.
- 10.17 All the costs associated with the assignment shall be part of Financial Proposal as per Point 10.15.1. These shall normally cover remuneration for all the Personnel, accommodation, air fare, equipment, printing of documents, etc.
- 10.18 The Financial Proposal includes all expenses and tax liabilities except GST. GST shall be paid as per actual to each bidder. Further, all payments shall be subject to deduction of taxes at source as per Applicable Laws.
- 10.19 **Submission of Tender:**

- i. Bidders shall submit the bid through email (in PDF format only)/ manual mode, on or before the closing date. HAFED will not be responsible for any delay in receipt of bids. Any bid received after the closing date and time shall not be entertained. In case, closing date of submission of bid happens to be a holiday due to some unforeseen circumstances, the bids will be received on the next working day at the same time.
- ii. The Bidders shall submit the Proposal in a bound form with all pages numbered serially and by giving an index of submissions. Each page of the submission shall be initialed by the Authorized Representative of the Bidder as per the terms of this RFP.

**10.20 Validity of Bids:**

The Bidder shall keep the proposal valid for acceptance for a minimum period of 120 Days after the last date of receipt of the Bids.

**10.21 Other Terms & Conditions:**

- i. Hypothetical and conditional bids will not be entertained and will be rejected summarily.
- ii. Department reserves the right to accept or reject all or any of the Tenders without assigning any reason.
- iii. There shall be no commitment of minimum quantity which can be ordered during currency of the contract. Supply orders shall be placed on the Bidder against the Contract for such quantities as may be decided by the Department.
- iv. All disputes concerning in any way with this EOI are subject to appropriate Courts at Chandigarh/ Panchkula Jurisdiction only.
- v. Partial bid won't be acceptable.
- vi. Any deviation to the terms & conditions of this tender won't be acceptable.
- vii. Consortium / Joint venture bid won't be allowed.

**10.22 Arbitration:**

In the event of any dispute or differences, the matter will be referred to the Managing Director, HAFED or its nominee.

**10.23 Late Bids:**

Bids received by HAFED after the specified time on Bid Due Date (BDD) shall not be eligible for consideration and shall be summarily rejected.

**10.24 Confidentiality:**

Information relating to the examination, clarification, evaluation, and recommendation for the selection of BIDDERS shall not be disclosed to any person who is not officially concerned with the process or is not a retained professional adviser advising HAFED in relation to matters arising out of, or concerning the Selection Process. HAFED shall treat all information, submitted as part of the Proposal, in confidence and shall require all those who have access to such material to treat the same in confidence. HAFED may not divulge any such information unless it is directed to do so by any statutory entity that has the power under law to require its disclosure or to enforce or assert any right or privilege of

the statutory entity and/or HAFED or as may be required by law or in connection with any legal process.

**10.25 Clarifications:**

- i. To facilitate evaluation of Bids, HAFED may, at its sole discretion, seek clarifications from any Bidder regarding its Proposal. Such clarification(s) shall be provided within the time specified by HAFED for this purpose. Any request for clarification(s) and all clarification(s) in response thereto shall be in writing.
- ii. If a Bidder does not provide clarifications sought under Clause 10.24 above within the specified time, its Proposal shall be liable to be rejected. In case the Proposal is not rejected, HAFED may proceed to evaluate the Proposal by construing the particulars requiring clarification to the best of its understanding, and the Bidder shall be barred from subsequently questioning such interpretation of HAFED.

**10.26 Indemnity:**

The Bidder / consultancy firm shall, subject to the provisions of the Agreement, indemnify HAFED, for an amount not exceeding value of the Agreement, for any direct loss or damage that is caused due to any deficiency in Services.

**10.27 Award of Consultancy:**

Generally, after selection, a Letter of Award (the "LOA") shall be issued, in duplicate, by HAFED to the Selected Bidder and the Selected Bidder shall, **within 5 (five) days** of the receipt of the LOA, sign and return the duplicate copy of the LOA in acknowledgement thereof. In the event the duplicate copy of the LOA duly signed by the Selected Bidder is not received by the stipulated date, HAFED may, unless it consents to extension of time for submission thereof, cancel the LOA and the next highest ranking Bidder may be considered.

**10.28 Commencement of Consultancy:**

Generally, the Consultant shall commence the Consultancy **within 7 (seven) Days** from the date of issuance of LOA, or such other date as may be mutually agreed. If the Consultant fails to commence the assignment as specified herein, HAFED may invite the second ranked Bidder for negotiations. In such an event, the LOA may be cancelled/ terminated.

**10.29 Proprietary Data:**

- i. Subject to the provisions of Clause 10.21, all documents and other information provided by HAFED or submitted by an Bidder to HAFED shall remain or become the property of HAFED. BIDDERS and the Consultant, as the case may be, are to treat all information as strictly confidential. HAFED will not return any Proposal or any information related thereto. All information collected, analyzed, designed, developed, processed or in whatever manner provided by the Consultant to HAFED in relation to the Consultancy shall be the property of HAFED.
- ii. All Knowledge/Data which come to their notice as part of engagement shall not be used outside without permission of HAFED
- iii. The Correspondence both Physical and Electronic shall be in the name of HAFED.
- iv. Dedicated official Mail ID mentioned in EOI shall alone be used for all correspondence associated with the engagement.

- v. The Consultancy shall not promote their Company in these correspondences and shall not disclose their Identity in any manner.

## **11. EVALUATION OF BIDS**

### **11.1 Evaluation of Technical Bids and Short-listing of BIDDERS**

- i. Technical bids of only those BIDDERS who fulfill the pre-qualification criteria without any condition shall be evaluated (1st Stage of evaluation).
- ii. The Technical Proposal will be evaluated on the basis of Bidder's past experience, Annual turnover, Project team, Quality certifications, Approach & methodology and Technical presentation (2nd stage of evaluation).
- iii. The scoring criteria to be used for evaluation shall be as follows:
