The technical bid will be opened on 28.07.2022 and the date for opening of the financial bid will be informed lateron.

- NOTE: 1. The bidder should have executed at least one work of 80% amount OR two works of 60% amount OR three works of 40% amount of similar nature in the last 5 financial years and current financial year of submission of bids shall be considered. Bidder shall have to submit proof of having successfully completed requisite number of works of specified amount by depositing requisite documents at stipulated time mentioned above.
  - 2. Contractor ID on Haryana Engineering Works Portal is mandatory for interested bidder to participate in tender for technical qualification, otherwise bid not be accepted.
  - 3. The bidder should upload the Latest Attested Affidavit from Notary (as per Annexure-A) that the agency / contractor has never been blacklisted (the affidavit should be submitted in technical bid)

- 2. Contractor ID on Haryana Engineering Works Portal is mandatory for interested bidder to participate in tender for technical qualification, otherwise bid not be accepted.
- 3. In case Financial bid is submitted but EMD has not been submitted by any bidder, the bid of that bidder will be rejected and the bidder would be debarred from further tendering in Hafed for a period of minimum one year.
- 4. Conditional tenders will not be entertained and are liable to be rejected.
- 5. The amount of earnest money shall be 1% of the estimated cost in case of Cooperative Labour & Construction Societies. The instructions regarding concession / facility to the Cooperative Labour & Construction Societies issued vide No.1214-C-7-2022/2747 dated 20.05.2022 are applicable in the said tenders.
