**2.4** Bid for a particular tender must be submitted online using the digital certificate (Encryption & Signing), which is used to encrypt and sign the data during the stage of bid preparation. In case, during the process of a particular tender, the user loses his digital certificate (due to virus attack, hardware problem, operating system or any other problem) he will not be able to submit the bid online. Hence, the users are advised to **keep a backup of the certificate** and also keep the copies at safe place under proper security (for its use in case of emergencies).

**2.5** In case of online tendering, if the digital certificate issued to the authorized user of a firm is used for signing and submitting a bid, it will be considered equivalent to a no-objection certificate/power of attorney /lawful authorization to that User. ## **B) Net Banking**

## **C) RTGS/ NEFT/OTC**

The bidder shall have the option to make the EMD payment via RTGS/ NEFT/OTC. Using this module, bidder would be able to pay from their existing Bank account through



RTGS/NEFT. This would offer a wide reach for more than 90,000 bank branches and would enable the bidder to make the payment from almost any bank branch across India.

I. Bidder shall log into the client e-procurement portal using user id and password as per existing process and selects the RTGS/NEFT payment option.

ii. Upon doing so, the e-procurement portal shall generate a pre-filled challan. The challan will have all the details that is required by the bidder to make RTGS-NEFT payment.

#### 1.0 **Back ground Information**

Hafed has set up a Sugar Mill of 2500 TCD capacity with Co generation of power to export 2MW power to state grid at Village Phaphrana near Assandh, District. Karnal, Haryana. The Mill is in operation since 2008-09. The capacity of the mill is 2500 TCD.

#### 2.0 **Invitation of Bids:**

- 2.1 Hafed is looking for reputed parties/bidders for sale of Approx.- 50,000 qtls. molasses, F.O.R. Sugar Mill, Assandh. The Party can quote molasses full or part quantity. The minimum molasses quantity to be offered by the bidders is 10,000 qtls.
- 2.2 Tenderers are also advised to study all technical and commercial aspects, instructions, forms, terms and specifications carefully in the tender document. They can inspect the material at Hafed Sugar Mill, Assandh on any working day. Failure to furnish all information required in the Tender Document or submission of a bid not substantially responsive to the Tender document in every respect will be at the tenderer's risk and may result in the rejection of the bid.
- 2.3 The Payment for Tender Document Fee INR 200/- (Rupees Two Hundred Only) and eService Fee Rs. 1000/- (Rupees One Thousand only (Non refundable) can be made by eligible bidders / contractors online directly through Debit Cards & Internet Banking Accounts and the Payment for EMD **Rs. 1,00,000/- (Rupees One Lac only) for molasses** can be made online directly through RTGS / NEFT and the bidder would remit the funds at least T + 1 working day (Transaction + One day) in advance to the last day and make the payment via RTGS / NEFT to the beneficiary account number as mentioned in the challan.

### **Procedure for submission of Bids**

3.1 The bids shall be submitted Online in two separate envelopes:

- Envelope 2: Commercial Bid

The bidders shall **quote** the prices in price bid format under Commercial Bid.

3.3 The committee is empowered to increase/decrease the quantity keeping in view the market trend of prices of molasses.

3.4 Hafed reserves the right to reject any /all tenders without assigning any reason whatsoever.

3.5 Any conditions of the firm sent along with the quotation, if any, shall not be binding on Hafed.

3.6 On acceptance of tender, the date of start of contract should be strictly adhered to otherwise, Hafed reserves the right to cancel the contract and forfeit the earnest money of the tenderer.

### **3.0 Payment and Penalty:-**

3.1 Lifting shall be against advance payment and full payment will have to be made within stipulated period. In case of delay in payment interest on balance payment will be charged @ 12% per annum for delay period.

3.2 In case of failure to lift the sold quantity in time, the party will be allowed to lift the balance stock within two weeks, effective from the last day of the above said lifting period and storage charges @ Rs. 1 per Qtl. Per week will be charged from the party. But the party will have to deposit the full payment before or on the last week of

the above said lifting period. Otherwise, the party stands liable for forfeiting the security amount.

3.3 The Party shall abide by rules and regulations in force by the Excise & Taxation Commissioner, Haryana from time to time. Right from the day of auction of Molasses till the entire auctioned stock is lifted.

3.4 The Party shall have no right claim for lifting of Molasses after cancellation of the allotment of Molasses due to the Policy/Decision of the State Govt. /Central Govt./ Any Court of Law.

4.0 **Lifting**

a. **Molasses:-** Lifting will started immediately from the next day of finalizing the tender. Lifting time schedule shall be as under:-

6.0 **Transportation:-**

The Tenderer will have to make his own arrangement for transportation of Molasses.

7.0 **Weighment:-**

The weighment shall be done at the factory weighbridge from 9.00A.M. To 5.00 P.M. on all the working days, except emergency.

8.0 **Rate:-**

Each bidder is to fill in final rate in his tender form and negotiation will be held only with highest-one bidder.

9.0 Disputes, if any arising out of the sale will be referred to the Managing Director, Hafed, whose decision thereon, shall be final and binding on both the Parties.

10.0 Sold Quantity is approximate it may increase or decrease.

11.0 The Molasses will be sold on 'As is where is' basis.

12.0 No conditional tender will be accepted.

If they violate this undertaking and the Sugar Mills come to know of such hike on their own/through their own resources, then the Sugar Mills shall be entitled to recover the double the difference in such rates on the entire quantity purchased alongwith cost and damages from tenderer.

4. The Tenderer would ensure that the entire quantity must be lifted from the Mills as per the Delivery Schedule provided to the Tenderer. In case of any delay in lifting of material as per delivery Schedule, a penalty @ Rs.2/- per bag per day will be imposed, security will be forfeited and the lapsed quantity will be sold on the risk and cost of the buyer.
5. That in case of stoppage of lifting by the Buyer, not only would the Security be forfeited, but also if risk purchase is to be made on the risk and cost of the supplier, then the credit balance lying with the Mill, would be liable to be adjusted against such risk purchase.
6. **Payment Terms :-**
  - (1) Sugar will be lifting from the sugar godowns of the mills including Excise duty/ GST etc.
  - (2) Period of lifting 10 days or negotiated.

**B. SPECIAL CONDITION FOR NEGOTIATIONS**

- 1.(a) The price discovery for the Rate Contract shall be generally determined based on the rates quoted by the H<sub>1</sub> bidder and the negotiations, if any, held with the highest bidder. However, the rate contract negotiations could be held up to H<sub>3</sub> bidder, if the difference between the H<sub>1</sub> quoted rates and those quoted by the H<sub>2</sub> and H<sub>3</sub> is within 5% of the H<sub>1</sub> quoted rates. - b) In cases where there is only one bidder for a particular item and the price quoted by such H<sub>1</sub> bidder is accepted by the indenting department as being reasonable, the order for the entire quantity such item could be placed on such bidder.
- c) In case, more than two firms are approved, the H<sub>1</sub> bidder, whose finally discovered price becomes the basis for making counter-offers to other qualifying bidders, would continue to be accorded priority for allocation of share quantities, which may go up to 50% of the total estimated quantity of the Rate Contract subject to his offered quantity, capacity to purchase orders / commitments in hand and previous track record.

- d) In cases where there are more than one bidders consenting to accept the H1 discovered price in response to the counter –offer, the quantities shall be allocated among H2 & above approved bidders, as the case may be, based on the principles of (i) H2 / H3 position (viz H2 bidder shall be preferred over H3 bidder & so on (ii) offered quantity, (iii) capacity to purchase, (iv) Sales turnover, (v) orders in hand, and (vi) previous track record in execution of orders (as per the information available in the DNIT).
- e) It may not be necessary to make a counter – offer of the discovered price to all the bidders quoting within 10% of the H1 quoted rates. Instead, such counter-offer may be restricted up-to H3 if they have the capacity to meet the entire order. However, if the H2 or H3 bidders do not accept the counter offered rates, the counter offer in that case could also be extended to other bidders whose quoted rates are within 10% price range. This is likely to increase the competitiveness.

**C. Sale preference**

Sale preference upto 50% of the tendered quantities may be allowed to the Industrial Units located in Haryana on the highest valid rates, provided:

1. Where more than one tenderer claim Sale Performance and fulfill all the above conditions, 50% quantity covered under sale preference may be divided between them on proportionate basis keeping in view the quantity /delivery period quoted by them.

- 2 In case successful bidder fails to lift the Sugar as per sale order or the terms mutually agree upon. Any loss suffered shall be at the cost of purchaser.

In that event the sugar mill will sell the material in open market at the risk and cost of the purchaser and the purchaser will be responsible for all the losses suffered by the mills on this account.

- 3.2. The tenderers are required to quote the price of Brown Sugar (BISS) per Qtls. F.O.R. Sugar Mill, Assandh, inclusive of all duties and taxes.
  - 3.3. The committee is empowered to increase/decrease the quantity keeping in view the market trend of prices of Brown Sugar (BISS).
  - 3.4. Hafed reserves the right to reject any /all tenders without assigning any reason whatsoever.
